1. By purchasing an entry, you agree to these terms and conditions. Any participation instructions form part of these terms and condition. Any entry not complying with these terms and conditions will be invalid. Kidney Cancer UK's decisions pursuant to these terms and conditions shall be final and binding.
2. You represent and agree that:
  - a. You are 18 years of age or over
  - b. You are a resident of the United Kingdom
  - c. You will not buy or purport to buy an entry in this raffle on behalf of anybody under the age of 18.
  - d. You will provide accurate entry and information, including your name and personal address.
3. You agree that you shall not be entitled to receive any prize if you are unable to substantiate to the Promoter your representations under paragraph 2.
4. Entry is open to all residents in the UK (including Kidney Cancer UK Volunteers) but excludes Kidney Cancer UK Trustees or directors, or Kidney Cancer UK employees or third parties each directly involved in the administration or management of the raffle, or with the ability to influence the raffle results.
